

#### **SPOZZ MISSION**





#### FIRST, IT'S IMPORTANT TO UNDERSTAND A FEW CONCEPTS

#### **BLOCKCHAIN TECHNOLOGY**

Blockchain is a technology; like a huge book of digital records; Computers that constantly store and update information; it can be public, private or hybrid and is immutable; the registered information cannot be changed or deleted.

#### NFT

NFTs are unique assets that cannot be modified or exchanged for another that has the same value, since no two NFTs are equivalent just as there are no two WORKS OF ART that are equivalent.

#### **TOKEN**


A token is a unit of value that an organization creates to govern its business model and give more power to its users to interact with its products, while facilitating the distribution and distribution of benefits among all its shareholders.

#### WALLET

It refers to a virtual wallet, wallet or purse in which we can manage our cryptographic assets.




# MUSIC AND DIGITAL ART SALES INCOME STREAM



HOW DO I EARN MONEY?

Similar to the "Master Rights", I will be able to sell "copies" of my digital art and songs, something like I used to do with the albums or with art prints, but digitally. These copies have a limited edition set by the artist. This makes the art/song and its limited edition copies a collector's item. But this time it's me as an artist selling my music directly to my community and fans and setting the prices myself.

HOW DO I EARN DO I EARN MONEY?

The community and fans can also sell any NFT they own. As long as they do this within the Spozz marketplace, the creator commission predetermined by the artist will be maintained. This cannot be guaranteed outside of the SPOZZ Marketplace, as the respective platform determines this.


### MUSIC STREAMS INCOME STREAM



HOW DO I EARN MONEY?


The artist can also earn for each stream on the platform. If she/he has not sold any license or copy, she/he will get 100% of the profits generated, if she/he has sold one or many of them, she/he will share the profits 50% with the buyers (fans/community).





Of course, fans will also be able to recommend or share songs and also earn money from it, because they will be able to issue a "non-exclusive" use license as a kind of sub-license that will have a pre-established value.

This is an example with Royalty of 5% set from the artist (can be between 0% - 50%). The percentage from the owner will be set accordingly, the 2% from SPOZZ are fix.

By registering and verifying as an artist, you can use the tools we provide to be creative, connect with your fans and benefit from your art as a unique brand. Our platform is designed to help musicians earn more money through direct distribution to their fan community through offering:

/ Featuring all Artist with a complete Artist Page (banner, text, profil picture, at least one Music NFT/Drop) with a post on Instagram, Twitter and LinkedIn.

/ Own free artist website (Landing Page, Shop, Fan Page) on SPOZZ.club.

/ Streaming App where users pay 1 cent for each song (after the introductory phase) and still save money.

/Incentives for song sharing (a lifetime license costs 20 Cents, and the sharing originator receives 4 Cents of commission) by fans (advertising by fans instead of paying for Facebook)

/ Other fan community tools such as fan chat, online release parties

/ Direct licensing of songs to end customers:

- Sales of Songs (Drops Price and fraction set by artist)
- Sublicensing (Sharing for 20 Cents)
- Streaming Revenue Participation (1 Cent per stream, evtl. Volume discount for heavy streamers)

/ Fans collect, trade, and invest in the songs


